This is an excellent opportunity to find out more about the local chapter of the NAWCC while getting a scarce opportunity to bid on 100s of clocks including cuckoos, shelf, novelty, kitchen, electric and many others.

**These sales are normally open only to members of the NAWCC. However, this sale will be open to the general public.**

**\*Coffee and donuts will be available.\***

Terms are cash between consignor and buyer. Neither Paul Auction Co. nor Chapter 47 will be handling any of the sale transactions other than to call bids. Because this is a charitable auction and I am donating my services for this sale, I am not representing it as a "Paul Auction Co." auction. As such, Chapter 47 has set forth the auction rules. Please read all of the sale specifics as follows:

1. Sellers must be members of Chapter 47, 3, 147
2. Sellers can list items for \$1 each item or lot. Seller will receive a number receipt during check in. The item will then be labeled with this number also.
3. Chapter 47 is not responsible for lost or damaged items.
4. Chapter 47 is not responsible for items bought or sold at the auction. Chapter 47 makes no claims of items condition or authenticity. All items will be sold.
5. Sellers can bid on their own item.
6. No reserves.
7. No buyers fees.
8. \$3 admission includes bid card, free with chapter 47 gold card
9. All transactions will be between buyer and seller. Chapter 47 assumes no responsibility in settling the sale.
10. All items must be of horological nature.
11. No items to be picked up until after the auction is over.
12. Announcements on day of sale take precedence over written notice.
